1. PRECAUTIONARY MEASURES FOR THE UNIVERSITY OF FUJAIRAH TO RECEIVE STUDENTS

1.1 General Restrictions:

1.1.1 *Green pass is not required to enter the UOF campus.*

1.1.2 *Students shall always adhere to national guidelines regarding policies developed to reduce the transmission risk.*

1.1.3 *Wearing face masks in open and closed spaces is now optional.*

1.1.4 *Adherence to the procedures approved by the relevant authorities when returning to the United Arab Emirates.*

1.1.5 *Disposable sanitizers and personal equipment shall be used in campus restaurants or cafés.*

1.1.6 *The information regulations shall be published on the website of the university and all its social media channels.*

1.2 Before Opening the Campus:

1.2.1 *Al Hosn app use will be limited to proof vaccination and test results upon request.*

1.2.2 *Termination of the thermal examination procedure for students and employees, and anyone who feels high temperature should not attend and obtain a sick leave if the result is negative.*

1.2.3 *Virtual awareness workshops shall be held for all students, academic staff, and employees.*

1.2.4 *The necessary medical equipment is available at campus clinics.*

1.2.5 *All employees, academic staff, and students shall undertake to declare if they contact with coronavirus patients, or if they return from abroad.*

1.3 Upon entering the campus:

- 1.3.1 *The Green pass is not required when entering the campus.*
- 1.3.2 *Wearing a mask is optional.*
- 1.3.3 *The UOF keeps all the following details (name, telephone number, identity number, and visit date) in visitor records.*

1.4 On campus:

- 1.4.1 *Wearing masks inside the campus is optional.*
- 1.4.2 *Wearing masks is mandatory in health facilities and centers of people of determination.*
- 1.4.3 *Each student must use his items only, such as stationery and a computer, and he does not have to use the items of a colleague or employee.*
- 1.4.4 *It is allowed to sit and wait in the cafeteria and waiting areas while adhering to precautionary measures.*
- 1.4.5 *Praying using personal mats is now optional.*
- 1.4.6 *The presence of the security and safety team continuously follows up and guides the students by following the precautionary measures and monitoring cases of violations of the precautionary measures and directing them.*
- 1.4.7 *The facilities, including the bathrooms, are cleaned and sterilized periodically throughout the day.*
- 1.4.8 *There is a refrigerator to keep packaged foods.*
- 1.4.9 *If any student feels any symptoms of an increase in temperature, severe headache, body aches, or coughing, he must stay away from his colleagues and go immediately to the health clinic at the university to examine his condition, evaluate his condition and isolate him in the health isolation room if it turns out that they are symptoms of corona and therefore instructions are followed Operation manual, as mentioned in the plan to deal with the emergence of positive cases and contacts.*
- 1.4.10 *Five days isolation for those who are infected with Covid 19 is implemented.*
- 1.4.11 *Availability of a clinic to follow up on the status of students in case of any complaint.*
- 1.4.12 *Availability of a health isolation room to isolate any infected or suspected case.*
- 1.4.13 *All instructions for prevention and sterilization must be followed, as shown in the internal guiding labels, such as washing hands constantly and sterilizing hands with alcohol.*

1.5 Precautionary measures inside the classrooms:

- 1.5.1 *Students must Listen to the instructions and educational advice from the doctor of the subject during the lecture, such as safety and security advice, maintaining public health, and the procedures to be followed to maintain your safety and the safety of your colleagues.*
- 1.5.2 *Any Student is not allowed to use his colleague's items and must use his items only.*
- 1.5.3 *Food and drinks should not be consumed in the classroom.*
- 1.5.4 *The classroom must be kept clean to ensure a clean and healthy learning environment.*
- 1.5.5 *When entering the classroom, students must enter quietly, orderly, and socially, without crowding.*
- 1.5.6 *When you leave the classroom, students must go out quietly, orderly, and socially, without crowding.*
- 1.5.7 *The presence of the security and safety team continuously regulates the movement of entry and exit and the extent of compliance with the instructions and precautionary measures to be followed.*
